Player ID: The players card number to be included for a re-registration, Transfer or Free-agent signing.

Player Status: One box must be ticked. Transfers must be accompanied by a completed transfer form.

Club Details: We are not psychic. You need to tell us which club and which age group the player is registering at.

Section B must be completed if a transfer.

Section C: Make sure that it is the player's details, not the parents! Full name and Date of Birth are a must.

2. Parent Declaration: You **MUST** have the parent's permission for a child to play.

3. Club Official Declaration: We do not know who has signed the form. The club official is stating that they have witnessed the signing by the player and the parent.

So, the form is completed correctly what else needs to go in the envelope?

- **Proof of age** - a photocopy of either: birth certificate, passport, medical card or a letter from the school on headed paper confirming name and date of birth
- **2 passport sized photos.** Please put team name and players name on the back. If you have four registrations in the envelope, how are we supposed to know which photo goes with each registration form?
- **A stamped envelope** addressed to RL Community Services, The Zone, St Andrews Road, Huddersfield, West Yorkshire, HD1 6PT.
- **A stamped self-addressed envelope** back to the person receiving the cards.

Make sure the postage on the envelopes is sufficient for the size of envelope and the weight of contents.
